### **RESOLUTION NO. 2021-5-1**

#### A RESOLUTION APPROVING VACATION OF A PORTION OF AN EASEMENT

WHEREAS, Three Lakes Water and Sanitation District ("District"), in the County of Grand, Colorado is a quasi-municipal corporation and political subdivision duly organized and existing under the Constitution and laws of the State of Colorado; and

WHEREAS, pursuant to C.R.S. § 32-1-1001(1)(f), the Board of Directors of the District has the power "[t]o acquire, dispose of, and encumber real and personal property including, without limitation, rights and interests in property, leases, and easements necessary to the functions or the operation of the special district . . ."; and

WHEREAS, the District owns easements across property in the Columbine Lake subdivision dedicated per the Easement Deed recorded at Reception No. 176299 in the real property records of Grand County, Colorado ("Existing Easement"); and

WHEREAS, the fee owners of the parcels described as Lot 62 and 63, Block 6, Columbine Lake Subdivision (the "Property") have applied to Grand County for approval of an amended final plat to combine Lots 62 and 63 into a single Lot 62A; and

WHEREAS, the owners of the Property have requested that the District vacate that portion of the Existing Easement which runs for a width of five feet on each side of the property boundary line between Lots 62 and 63, as described in **Exhibit A**, attached hereto and incorporated herein; and

WHEREAS, the Board wishes to hereby approve the vacation of such portion of the Existing Easement.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Three Lakes Water and Sanitation District, Grand County, Colorado as follows:

- 1. The District hereby vacates that portion of the Existing Easement consisting of strip of land along the lot line between Lots 62 and 63, Block 6, Columbine Lake Subdivision, which runs five (5) feet in width on each of Lots 62 and 63. All other portions of the Existing Easement granted by Reception No. 176299 remain in full effect without amendment, unless previously vacated.
- 2. The Board approves vacation of such portion of the Existing Easement as described above and authorizes the District Vice Chairman to sign the Quit Claim Deed, attached hereto **Exhibit B** and incorporated herein, which shall be recorded in the real property records of Grand County.
